SUMMARY

July Training: All officers completed annual drivers training. Five officers continued their field training this month. Three officers will depart for the Iowa Law Enforcement Academy in August. All officers attended their gas mask fitting. Three supervisors attended the City of Ames leadership fundamentals training. Several officers attended a training workshop hosted by the Story County Attorney’s Office. Two officers attended traumas in law enforcement.

July Outreach and Engagement: Several officers attended summer block parties throughout the month. Officers assisted with the July 4th parade. One officer presented on workplace safety to Merck employees. Officers presented active shooter training to Mary Greeley Medical Center. Officers attended several outreach events throughout the month of August to include events at Eagles Loft Early Learning Center, All Aboard Kids Camp, and ChildServe. Officers were also represented at the Iowa Games.

USE OF FORCE DETAIL

Incident 1:

Use of Force: Display of firearm

Date: July 1, 2024, at 19:34

Details: Officers located a man who had a warrant for domestic assault with strangulation. The man had cautions on the warrant for being armed and dangerous. Officers approached the male, one officer drew his firearm and ordered the male to turn around and place his hands behind his back. The male complied and the officer holstered his firearm, and no other use of force was needed.

Charges: Aggravated Domestic Assault with Strangulation

Demographics: 19-year-old white male

Incident 2:

Use of Force: Deployment of taser, Knee strikes, Grabbed subject

Date: July 4, 2024, at 23:22

Details: Officers were dispatched to a local hotel reference an individual who was not supposed to be there. While attempting to identify the people involved who did not have permission to be on the premise. The male provided more than one name and date of birth to officers. Officers decided to place the male under arrest for providing false identification information and the male began to physically resist officers. One officer deployed a taser while the other delivered knee strikes while still fighting to get the male secured in handcuffs. Eventually, the officers were able to get the male’s hands behind his back and secured him in handcuffs. One officer sustained a minor injury to his finger. The male was found to have felony warrants from an outside agency.

Charges: Arrest Warrant-Other Agency x 2, Delivery of Controlled Substance-Meth, Interference with Official Acts, Interference with Official Acts Causing Injury, Providing False Identification Information x 3

Demographics: 28-year-old white male

Incident 3:**Use of Force: Display of pepper spray, Grabbed subject****Date: July 14, 2024, at 01:50**

Details: An officer was on routine patrol when they observed a fight in progress. The officer contacted a male who was still engaged in fighting behavior once the officer exited their patrol car. The officer grabbed the male and instructed him to place his hands behind his back to which the male refused and began physically resisting the officer. The officer pushed the male against a car to gain control of him. The male continued resisting so the officer displayed pepper spray and at that point the officer's backup arrived. Officers were then able to secure the male in handcuffs without further incident.

Charges: Disorderly Conduct, Interference with Official Acts

Demographics: 26-year-old black male

Incident 4:**Use of Force: Grabbed subject, Handcuffed subject****Date: July 14, 2024, at 16:08**

Details: Officers were dispatched to a local residence to assist paramedics with a combative patient. Officers grabbed the female's wrists and placed her in handcuffs to prevent injury to staff and the patient. Officers assisted in getting the patient to the hospital for a mental health evaluation. No other use of force was needed.

Charges: None

Demographics: 16-year-old black female

Incident 5:**Use of Force: Display of firearm, Grabbed subject****Date: July 17, 2024, at 15:21**

Details: Officers assisted an outside agency with a drug investigation. A traffic stop was initiated on the male subject and officers displayed their firearms due to the nature of the investigation. Upon contact with the male, the male tried to reach into his pockets at which point officers grabbed the male and secured him in handcuffs. No other use of force was needed. The case remains under investigation.

Charges: Under Investigation

Demographics: 33-year-old white male

Incident 6:**Use of Force: Grabbed subject, Handcuffed subject****Date: July 17, 2024, at 21:50**

Details: Officers were dispatched to an intersection for reports of female juveniles fighting. Upon arrival, officers located two females on the ground physically fighting one another. Officers pulled one female off the other female, but the female continued to act in an aggressive manner. Due to the aggressive behavior the female continued to display, she was placed in handcuffs for her safety and the safety of others.

Charges (Juvenile Referral): Disorderly Conduct

Demographics: 14-year-old black female

Incident 7:**Use of Force: Display of firearm****Date: July 18, 2024, at 12:39**

Details: Officers assisted an outside agency with a drug investigation. A traffic stop was initiated on the male subject and officers displayed their firearms due to the nature of the investigation. The male eventually complied with officers and no other use of force was needed. The case remains under investigation.

Charges: Under Investigation

Demographics: 46-year-old white male

Incident 8:**Use of Force: Display of firearm, Display of taser, Grabbed subject****Date: July 19, 2024, at 03:26**

Details: Officers were dispatched to a local apartment they had been called to earlier in the day in reference to a domestic disturbance. The female half was breaking the window out of the sliding glass door. The female left prior to officer arrival. Officers were called back a third time. Officers were advised the female was inside the apartment with a knife. Officers approached the apartment, and one officer had their firearm drawn and another officer had their taser drawn. Upon contact with the male and the female, the officers holstered their weapons and were able to grab the female and secure her in handcuffs. The female was arrested for interference with official acts.

Charges: Interference with Official Acts

Demographics: 20-year-old white female

Incident 9:**Use of Force: Grabbed subject, Handcuffed subject****Date: July 20, 2024, at 19:53**

Details: Officers were dispatched to a local youth shelter reference a disorderly juvenile with a broomstick. The juvenile had damaged property and was threatening to kill himself and others. Officers attempted to deescalate, but he continued to escalate. Officers forced the juvenile against a wall to prevent him from injuring himself or others. The juvenile continued to resist and refused to let go of the broomstick. Officers directed the juvenile to the ground and were able to remove the broomstick from his grasp and secure him in handcuffs. The juvenile was transported to a local hospital for a mental health evaluation.

Charges (Juvenile Referrals): Criminal Mischief 5th Degree, Interference with Official Acts

Demographics: 14-year-old white male

Incident 10:**Use of Force: Display of pepper spray, Grabbed subject****Date: July 24, 2024, at 01:05**

Details: Officers were dispatched to a local business regarding a male who had started a fire outside. Officers arrived on scene and located a male carrying a butane torch. The male walked officers over to his encampment where officers saw drug paraphernalia. Officers ordered the male to place his hands behind his back, but he refused. Officers displayed their pepper spray and ordered the male to comply, but he moved closer to the officers. Officers then holstered their pepper spray and grabbed the male. The male became physically resistive. Officers directed the male to the ground and secured him in handcuffs.

Charges: Possession of Controlled Substance, Possession of Drug Paraphernalia, Interference with Official Acts

Demographics: 54-year-old white male

Incident 11:**Use of Force: Grabbed subject, Handcuffed subject****Date: July 24, 2024, at 04:34**

Details: Officers were dispatched to a parking lot of a local apartment complex regarding individuals who were looking in cars. Officers located some juveniles in the area matching the descriptions provided by the caller. Officers observed the individuals had several items in their pockets. Officers asked to see what was in their pockets and one of the juveniles took out an unlabeled pill bottle and attempted to throw it. Officers grabbed the juvenile's wrists and the juvenile tried pulling away from officers. Officers placed the juvenile in handcuffs. The pill bottle contained a controlled substance. Another juvenile had marijuana and paraphernalia in their possession. Two juveniles were issued juvenile referrals and released to a parent.

Charges (Juvenile Referrals): Possession of Controlled Substance, Possession of Drug Paraphernalia, Interference with Official Acts

Demographics: 17-year-old white male, 16-year-old white female

Incident 12:**Use of Force: Display of taser, Grabbed subject****Date: July 27, 2024, at 16:08**

Details: Officers were dispatched to a male in the roadway who kept walking out in front of traffic. Officers located the male in the middle of the roadway and gave him commands to comply. The male refused to comply and continued walking toward officers. One officer drew their taser and continued giving verbal commands. The male then turned away from officers. The officer holstered their taser and went hands on with the male. The male became physically resistive, and officers took the male to the ground to gain control of him. The male was ultimately secured in handcuffs.

Charges: Disorderly Conduct, Public Intoxication, Interference with Official Acts

Demographics: 47-year-old white male

*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.
