

# Appeal of a Decision of the Zoning Enforcement Officer

**Application Packet** 

Appeals to the Zoning Board of Adjustment may be taken by any person aggrieved, or by any officer, department, or board of the City affected by any decision of the Zoning Enforcement Officer per Ames Municipal Code Section 29.1403 (7) and (8). **Such appeal shall be** *submitted within 30 days of the decision of the Zoning Enforcement Officer.* 

<u>Application Packet</u> Complete and submit <u>all the required materials</u> that are a part of this Application Packet. Failure to do so will result in a delay in accepting your appeal until the application is complete.

The Application Packet for an *Appeal of a Decision of the Zoning Enforcement Officer* includes the following:

- Application Form (This form must be filled out completely for all applications)
- Supporting Information (Sufficient facts must be presented to support the appellant's position, this will be transmitted to the Board)
- 1. <u>Board Meetings</u> The Zoning Board of Adjustment conducts a public hearing and makes the final decision based on the standards in the Ordinance. The Board meets on the second Wednesday of the month at 6:00 p.m. in the City Council Chambers. Additional meetings may be held on the fourth Wednesday of the month, April through October.

### 2. Application Process/Fee

#### The filing fee of \$75.00 is required at the time the application is submitted

The Zoning Board of Adjustment may grant an Appeal, provided the Board finds that there is an error in any order, requirement, decision, or determination made by an administrative official in the enforcement of Chapter 414 of the Code of Iowa or of any ordinance adopted pursuant thereto. This Appeal will not be granted unless sufficient facts are presented in this application and at the Zoning Board of Adjustment hearing to support a position finding by the Board.

Concurrence with this Appeal by the Zoning Board of Adjustment in no way absolves the applicant from subsequently obtaining the necessary building permits or other permits from the City of Ames or from any other applicable agency.

# **Appeal of a Decision of the Zoning Enforcement Officer**

Supporting Information

As provided by Section 414.12 of the Iowa Code, Section 29.1403(7)(a) of the Zoning Ordinance grants power to the Zoning Board of Adjustment to hear and decide appeals where it is alleged that there is an error in any order, requirement, decision, or determination made by an administrative official in the enforcement of the Zoning Ordinance.
