November Training: All officers attended implicit bias training. All officers completed their annual CPR certification. Three officers continued their initial training at the Iowa Law Enforcement Academy (ILEA). These officers will graduate from ILEA on December 13, 2024. Several supervisors attended Leadership Fundamentals training conducted by the City of Ames.

November Outreach and Engagement: Three officers met with Ames Pride regarding future events and collaboration. The mental health advocate worked with community partners to conduct homeless outreach. The intern coordinators interviewed several applicants for next semester's internship opportunities. One officer conducted ID talks. One officer attended Scout Hero Day. One officer spoke with Gilbert Elementary about the Bill of Rights and policing. Tours of the PD and fingerprinting were conducted for a group of Ames homeschooled children.

USE OF FORCE SUMMARY

Incident 1:

Use of Force: Forced to sit on curb

Date: November 1, 2024, at 00:58

Details: Officers were performing foot patrol in the Campustown area. A man came up the officers and was being belligerent. Officers had already dealt with the man earlier in the night and he had been drinking. He apparently had continued drinking after the first encounter. After asking the man to go home, he continued being belligerent and grabbed the officer. At this time, he was placed under arrest. While waiting for a transport vehicle, officer forced the man to sit on the curb while waiting for his safety.

Charges: Public Intoxication and Interference with Official Acts

Demographics: 21-year-old white male

Incident 2:

Use of Force: Pointed Taser

Date: November 1, 2024, at 01:31

Details: Officers were dispatched to a business for a report of a fight. Officers learned a man had entered the business and hit his girlfriend in the face. Once the suspect was identified, the officer pointed a Taser at the man until another officer arrived, and he was placed in handcuffs.

Charges: Domestic Assault with Injury, Harassment 1st Degree, Public Intoxication

Demographics: 29-year-old white male

Incident 3:

Use of Force: Pepper spray and Taser deployment

Date: November 1, 2024, at 12:18

Details: Officers were dispatched to a domestic situation at a private residence. The female victim reported being assaulted by her boyfriend. Officers forced entry into the residence where the man attempted to keep the door closed and then continued to resist. Pepper spray was used, as well as a Taser to gain control of the man. The man had several weapons close to him.

Charges: Domestic Assault with Strangulation, Interference with Official Acts
Demographics: 27-year-old white male

Incident 4:

Use of Force: Grabbed subject/Took to Ground

Date: November 4, 2024, at 11:18

Details: Officers were dispatched to a business where it was reported a man, and women were fighting in the parking lot. As officers approached, the man and woman attempted to walk away. The couple then tried to conceal controlled substances in a garbage can. The male was placed under arrest. However, when an officer attempted to place the female under arrest, she resisted, and the officer took her to the ground to gain control and place her in handcuffs. The male then started suffering an overdose and was transported to the hospital for treatment.

Charges: Controlled Substance Violation, Possession of Drug Paraphernalia, Interference with Official Acts
Demographics: 25-year-old-white-female

Incident 5:

Use of Force: Grabbed subject/Took to Ground

Date: November 7, 2024, at 08:17

Details: Officers were dispatched to a private residence for a domestic situation between a mother and daughter. When officers arrived, they confirmed a Protective Order existed for the daughter. While attempting to arrest her, she pulled away and officers grabbed her and took her to the floor to control her and place her in handcuffs.

Charges: Contempt of Court – Violation of No Contact or Protective Order
Demographics: 58-year-old Asian male

Incident 6:

Use of Force: Wrist Lock

Date: November 9, 2024, at 01:52

Details: Officers were dispatched to a hotel for a disorderly patron. Officers located the man who appeared intoxicated. Officer attempted to place him under arrest for the damage he had done and public intoxication. The man tensed up and an officer used a wrist lock to gain control to place him in handcuffs.

Charges: Criminal Mischief, 5th Degree, Public Intoxication
Demographics: 30-year-old white male

Incident 7:

Use of Force: Displayed Taser

Date: November 11, 2024, at 07:33

Details: Officers were dispatched to a business for a report of a burglary in process. When officers arrived, workers from the business had confronted the suspect and there was a struggle. An officer drew their Taser, and the man was placed in custody.

Charges: Burglary 3rd Degree, Tampering with a Motor Vehicle
Demographics: 39-year-old white male

Incident 8:

Use of Force: Displayed Taser

Date: November 12, 2024, at 01:08

Details: Officers were dispatched to a facility for three juveniles who were out of control. It took a significant amount of time to attempt to deescalate one of the juveniles and significant damage was done to the facility. Eventually, officers were able to grab the juvenile and get him controlled after he assaulted several officers.

Charges: Criminal Mischief, 2nd Degree, Interference with Official Acts, Assault, Assault on a Peace Officer
Demographics: 16-year-old white male

Incident 9:**Use of Force: Weapons drawn****Date: November 13, 2024, at 20:33**

Details: While serving a search warrant at an apartment, an officer entered to begin the search and holstered their weapons once they were able to secure the premise without incident.

Charges: Possession of a Controlled Substance, Possession of Drug Paraphernalia, Felon in Possession of a Firearm
Demographics:

Incident 10:**Use of Force: Placed in handcuffs****Date: November 17, 2024, at 18:40**

Details: Officers were called to a medical facility for a report of an out-of-control patient. Officers assisted by placing the male in handcuffs so he could not continue to assault staff. Later, when the man calmed down, the handcuffs were removed.

Charges: None

Demographics: 42-year-old black male

Incident 11:**Use of Force: Grabbed subject****Date: November 20, 2024, at 09:09**

Details: Officers were called to a school for an out-of-control student. An officer grabbed the student to stop him from assaulting staff members.

Charges: Disorderly Conduct

Demographics: 12-year-old white male

Incident 12:**Use of Force: Weapons drawn****Date: November 22, 2024, at 20:28**

Details: Officers were called to an apartment complex for the report of a shooting. Officers quickly determined a shooting had taken place and were given a description of the suspect who was on foot in the area. Officer located the man attempting to hide in some tall weeds. Officers had their weapons drawn while taking the man in custody.

Charges: Attempted Murder, Felon in Possession of a Firearm

Demographics: 33-year-old black male

Incident 13:**Use of Force: Grabbed subject****Date: November 24, 2024, at 23:26**

Details: Officers responded to a residence for a dispute. When they arrived, they found a female who had taken items from the residence. Eventually, it was decided to detain the female, and she resisted. Officers had to grab her to put her in custody. Officers then found drug paraphernalia and she was arrested. When officers attempted to place her in the patrol car, she resisted again, and officers had to push her into the car for transport to the jail.

Charges: Theft 2nd degree, Possession of a Controlled Substance, Possession of Drug Paraphernalia

Demographics: 33-year-old white female

Incident 14:**Use of Force: Taken to ground****Date: November 30, 2024, at 23:58**

Details: Officers responded to an apartment complex for a report of a disorderly male. The male was located and had been drinking. Officers determined the man was intoxicated and attempted to place the man under arrest. The man attempted to head butt one of the officers and was taken to the ground to be handcuffed.

Charges: Assault on Peace or Fire Fighter, Disorderly Conduct, Public Intoxication

Demographics: 24-year-old white male

*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.
