February Training: All officers attended de-escalation training. Several command officers attended the City of Ames "Leadership Fundamentals" training. One officer completed phase 3 of field training. One officer completed field training and was assigned to shift 1. One sergeant instructed an ARIDE (impaired driving) course. Two officers assisted with firearms training at the Iowa Law Enforcement Academy (ILEA). One officer attended the Heartland Tactical Officers Association (HTOA) conference. One officer attended the tactical medicine course at ILEA. One officer assisted ILEA with medical scenarios. One supervisor attended, "5 Skills Every Public Safety Leader Needs to Succeed."

February Outreach and Engagement: Two officers attended local career fairs. Officers conducted ID training for local bar businesses and assisted the Iowa Alcohol Beverages Division (ABD) with bar inspections. One officer spoke with a local cub scout pack.

USE OF FORCE DETAIL

Incident 1: 25000379

Use of Force: Grabbed subject

Date: February 3, 2025, at 18:48

Details: Officers responded to a business for a possible robbery. The suspect was identified as juvenile and was known to police. He was later located. The juvenile damaged public property and picked up a piece of metal and threatened to hit an officer. Officers were able to grab him and place him in custody. The juvenile then spit on the officers.

Charges: Assault on a Peace Officer, Criminal Mischief 5th Degree, Interference with Official Acts

Demographics: 15-year-old white male

Incident 2: 25000398

Use of Force: Grabbed subject

Date: February 5, 2025, at 14:27

Details: Officers were called to a business to investigate a theft. Two suspects were identified. An officer located a female suspect. The suspect tried to walk away, and the officer grabbed her and placed her in handcuffs.

Charges: Theft 5th, Possession of a Controlled Substance, Possession of Drug Paraphernalia

Demographics: 23-year-old white female

Incident 3: 25000404

Use of Force: Pointed Duty Firearm during high risk stop

Date: February 5, 2025, at 20:58

Details: An officer located a stolen vehicle and initiated a high risk stop which involved pointing their duty firearm at the driver. The driver complied with orders given. However, during the encounter, the driver needed medical attention which was called to the scene. He was evaluated by medical and later released.

Charges: Theft of a Motor Vehicle

Demographics: 46-year-old white male

Incident 4: 25000440**Use of Force: Grabbed subject****Date: February 9, 2025, at 00:19**

Details: Officers were conducting bar checks in the Campustown area. A male approached the officers saying they needed help at one of the establishments. Officers found a man being held down by two other people. Officers took over the interaction to investigate what happened. The man was eventually arrested for Public Intoxication and attempting to fight several people. As officers escorted him to the car, he kicked one of the officers. He was grabbed and then forced into a squad car.

Charges: Assault on a Peace Officer, Disorderly Conduct, Public Intoxication

Demographics: 21-year-old white male

Incident 5: 25000516**Use of Force: Grabbed subject****Date: February 15, 2025, at 02:39**

Details: Officers were responded to a report of a dispute at a residence. After being called several times, it was determined that one party had committed Harassment in the 2nd Degree. She was placed under arrest. She attempted to pull away and was grabbed by the officers.

Charges: Harassment 2nd Degree

Demographics: 26-year-old-white female

Incident 6: 25000532**Use of Force: Grabbed subject****Date: February 16, 2025, at 15:07**

Details: Officers were called to a business for a report of a person acting in a suspicious manner. The person had dropped his wallet, so officers were able to run his information before arrival showing an active arrest warrant. As officers arrived on scene, the man fled. Officers closed in and the man caused damage to store shelves. Officer grabbed the man and were eventually able to place him in handcuffs.

Charges: Criminal Mischief 5th Degree, Interference with Official Acts, Warrant Arrest

Demographics: 34-year-old-white male

Incident 7: 25000543**Use of Force: Pointed Duty Weapon****Date: February 17, 2025, at 18:35**

Details: An officer located a wanted man and attempted a traffic stop on him. The man stopped his vehicle but then fled on foot. The officer followed him, and the man stopped and turned around to face the officer. The officer drew his duty weapon and gave the man commands. The man followed the commands and was taken into custody.

Charges: Warrant Arrest

Demographics: 51-year-old-white male

Incident 8: 25000551**Use of Force: Grabbed subject****Date: February 18, 2025, at 18:35**

Details: Officers responded to the hospital for a combative patient. Officers assisted in securing the man so he could not hurt staff.

Charges: No Charges

Demographics: 27-year-old-white male

Incident 9: 25000576**Use of Force: Grabbed subject****Date: February 21, 2025, at 12:19**

Details: Officers were called to a residence for a report of domestic violence. After an initial investigation it was determined who the primary physical aggressor was. Officers attempted to place the man under arrest and he pulled

away. Officers grabbed the man and were able to place him in handcuffs. He continued to resist trying to grab gear on the officers and kick them. He was placed in a squad and taken to jail.

Charges: Aggravated Domestic Abuse, Interference with Official Acts

Demographics: 45-year-old-white male

Incident 10: 25000569

Use of Force: Drew Duty Weapon

Date: February 22, 2025, at 18:35

Details: Officers had weapons drawn during a search warrant.

Charges: Assist Other Agency

Demographics: 25-year-old-black male

Incident 11: 25000632

Use of Force: Drew Duty Weapon

Date: February 25, 2025, at 23:56

Details: Officers were called to a residence for a report of domestic violence. The male half was attempting to hide from officers. He was eventually found in the residence, and an officer drew their weapon but did not point it at the man until they could determine he was unarmed. He was found to be the primary physical aggressor and was taken into custody without further incident.

Charges: Domestic Assault with Injury

Demographics: 43-year-old-white male

*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.

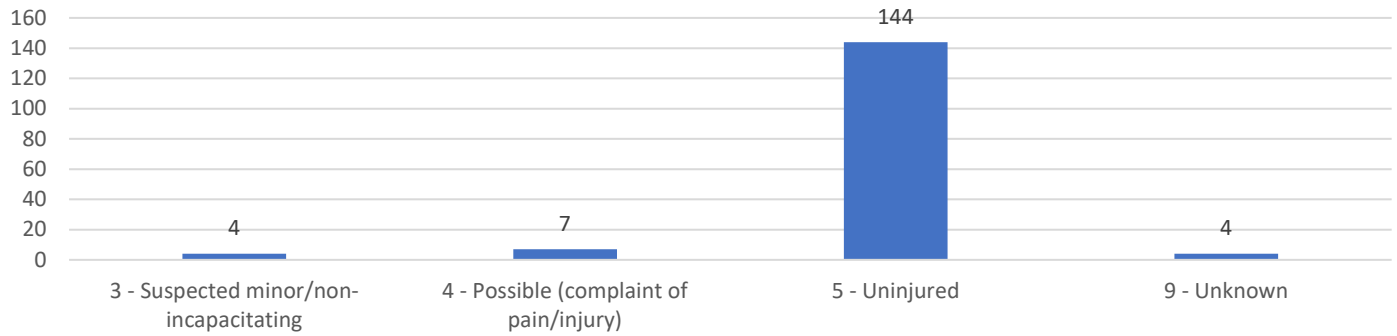
Airbag Deployment



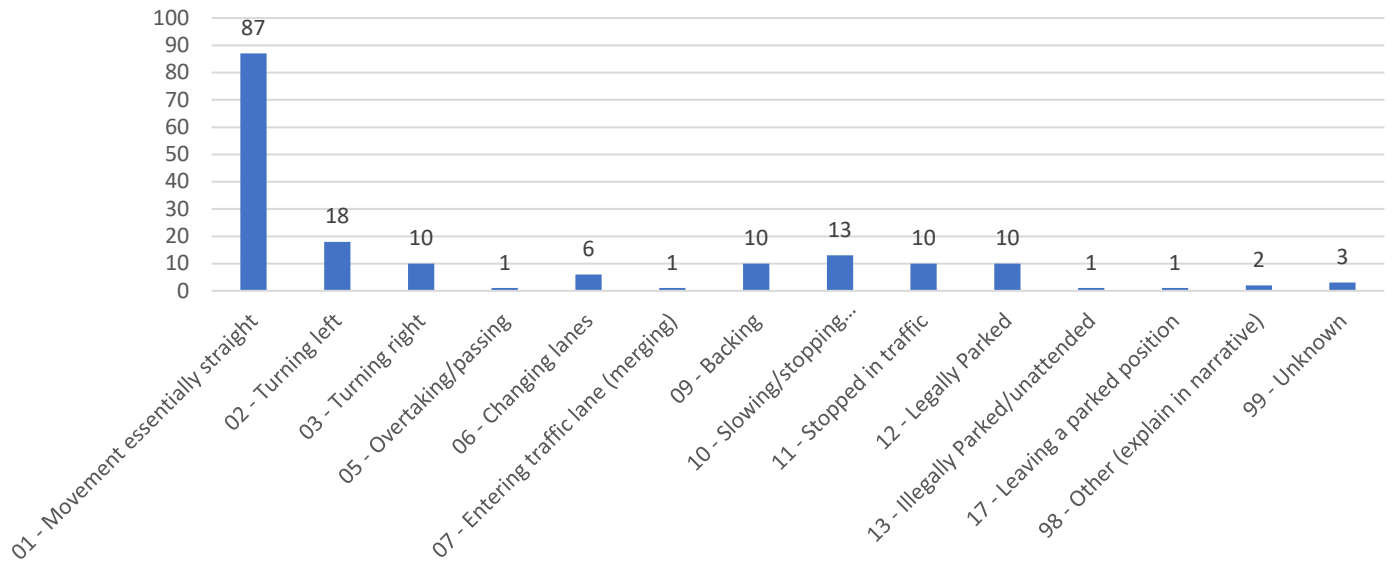
